
St. Mary's Welcomes...

Thank you to our Recreation Department

During the last few months, the Recreation team which includes staff from the Medical Day Care Program have gone above and beyond with keeping the residents connected to their school and their families. They adapted morning recreation programming to encompass PS 23's Distance Learning

plan. On a daily basis, PS 23 staff communicate with Recreation and MDHC staff through google classroom and email, they provide lesson plans that the St. Mary's team follows to ensure the work gets completed. Each unit has adapted a unique way of delivering education to the residents during this unprecedented time. Weekly Zoom calls are conducted to allow for real time video lessons with their teachers. On Top of virtual learning, this team also connects the residents to their families through Face Time, skype and email. Most of the time the visits are pre scheduled but are also done as needed based on the resident and family need. They have been facilitating 45 – 50 calls a day. Staff encourage families to bond during the visits by reading, singing and looping in extended family

members to the calls. Families have also emailed artwork from siblings and photos of their families which are printed and hung at bedside and if they are unable to connect with a family virtually, they will email pictures of the resident to the family.
